BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

Application of SAN DIEGO TRANSIT SYSTEM, a corporation, for authority to revise certain of its school routes.

Application No. 45114 (Filed January 15, 1963)

<u>OPINION</u>

Applicant requests authority to make several changes of its presently authorized routes serving the following schools:

> Route 21 - Crawford Senior High School Route 23 - Kearny Senior High School

Route 26 - Mission Bay Senior High School

Route 25 - Mission Bay Senior High School Route 27 - Point Loma Senior High School Route 29 - Collier Junior High School Route 31 - Gompers Junior High School Route 39 - Mann Junior High School Route 41 - Clairmont Senior High School

and to operate three routes which will serve the following schools which were opened in September of 1962:

Route 32 - Einstein Junior High School Route 38 - Madison Senior High School

Route 42 - Morse Senior High School

The proposed route changes were made necessary by reason of operational experience, convenience of the pupils, and the construction of new schools with the attendant reassignments. In some instances discontinuance of portions of present routes is due to lack of patronage.

The application has been served on the city and school authorities and there are no protests. The San Diego City School District and the Commission staff approve the changes.

The Commission having considered the matter, finds that public convenience and necessity require that applicant establish and operate its passenger stage service over and along the proposed routes. A public hearing is not necessary.

ORDER

IT IS ORDERED that San Diego Transit System, a corporation, may reroute and/or establish the following routes:

Route 23 - Kearny Senior High School
Route 26 - Mission Bay Senior High School
Route 27 - Point Loma Senior High School
Route 29 - Collier Junior High School
Route 31 - Gompers Junior High School
Route 32 - Einstein Junior High School
Route 38 - Madison Senior High School
Route 39 - Mann Junior High School
Route 41 - Clairmont Senior High School
Route 42 - Morse Senior High School

as set forth in Appendix A attached hereto and made a part hereof, and Appendix A of Decision No. 55090 is hereby further amended by incorporating therein
