
Applicant requests authority to reroute a portion of the San Pedro Harbor City Line in the business district of San Pedro. This line is a shuttle service between the present Western Greyhound agency depot at 254 West 6th Street, San Pedro and Harbor City. The agency depot will be moved to 507 West 8th Street, and this will require the proposed downtown route change. The new location is more convenient for passengers using the service. The application is not opposed and the City of Los Angeles Board of Public Utilities and Transportation and the Commission staff approve the change.

We find the proposed change to be in the public interest. The application will be granted. A public hearing is not necessary.

Section 2. REGULAR SERVICE -ROUTE DESCRIPTIONS

*ROUTE NO. 1 - SAN PEDRO-HARBOR CITY LINE

From the Western Greyhound Lines' commission agency depot at 507 West Eighth Street, San Pedro, thence via Eighth Street, Pacific Avenue, First Street, Western Avenue, and Pacific Coast Highway (U.S. Highway 101) to Western Greyhound Lines' commission agency depot at Frampton Avenue, Harbor City.

Return via the reverse of the going route to the intersections of Seventh Street and Pacific Avenue, thence via Seventh Street, Grand Avenue, and Eighth Street to Pacific Avenue.
