## SUPPLEMENTAL OPINION AND ORDER

Good cause appearing,

IT IS ORDERED that:

- 1. Minimum Rate Tariff No. 9-A (Appendix "B" of Decision No. 55256, as amended) is hereby further amended by incorporating therein, to become effective July 6, 1963, Third Revised Page 13 attached hereto and by this reference made a part hereof.
- 2. Tariff publications resulting in increases required or authorized to be made by common carriers as a result of the order herein may be made effective not earlier than the tenth day after



the effective date of this order, on not less than ten days' notice to the Commission and to the public; that such tariff publications as are required shall be made effective not later than July 6, 1963; that as to increases which are authorized but not required, the authority herein granted shall expire unless exercised within sixty days after the effective date of this order; and that tariff publications resulting in reductions may be made effective not earlier than the tenth day after the effective date of this order, and may be made effective on not less than ten days' notice to the Commission and to the public if filed not later than sixty days after the effective date of the minimum rate tariff page incorporated in this order.

3. In all other respects the aforesaid Decision No. 55256, as amended, shall remain in full force and effect.

This order shall become effective twenty days after the date hereof.

## APPLICATION OF TARIFF - COMMODITIES (Concluded) (Items Nos. 50 and 60)

\*Rates in this tariff apply for the transportation of all commodities except the following:

Furniture, household appliances and other home furnishings transported from retail stores or retail store warehouses where they have been sold at retail by a retail merchant, or transported from retail customers to retail stores, or retail store warehouses,

Liquids, compressed gases, commodities in semi-plastic form and commodities in suspension in liquids, in bulk in tank trucks, tank trailers, tank semi-trailers or a combination of such nighway vehicles,

Mushrooms, fresn. (not cold pack nor frozen),

Newspapers, newspaper supplements, sections or inserts (not scrap nor waste),

\*Nuts, in the shell,

\*Nuts, field shelled (rough shelled, with or without removal of broken shells, dirt, residue, or foreign material, and not cleaned nor further processed),

Property shipped to or from producers of motion pictures or television shows when transported subject to the rates, rules and regulations provided by Decision No. 33226, in Cases Nos. 4246 and 4434, as amended,

Property of the United States, or property transported under an agreement whereby the United States contracted for the carrier's services,

Property transported to a United States Post Office for mailing, United States mail transported from a post office to the addressee thereof, and United States mail transported for the Post Office Department under contract,

Telephone directories,

Used property, viz.: household goods, personal effects, furniture, musical instruments, radios, television sets, and office and store fixtures and equipment as described in and for which rates are provided in minimum Rate Tariff No. 4-A, and used property as described therein of state, county or municipal governments, or transported under an agreement whereby the governments contracted for the carrier's services,
