Application of AIRPORT COACH SERVICE, a corporation, operating under an existing certificate of public convenience and necessity to modify and extend its certificates of public convenience and necessity as a passenger stage corporation, for an in-lieu certificate.

OPINION

By this application, as amended, authority is sought to provide express bus service from the Disneyland Hotel, Anaheim, via the most direct and appropriate route or routes to the Sam Diego Freeway, thence along the Sam Diego Freeway and Century Boulevard to the Los Angeles International Airport. The proposed new route will result in a reduction in running time of from 85 minutes to 60 minutes in each direction. Due to this reduction in running time it will be possible to provide more frequent service and increase the number of daily trips from 18 to 23 with the same number of buses. Applicant also requests authority to supplement its present through service with a shuttle service to and from Disneyland Hotel. Presently authorized routes would be used. All presently authorized points will continue to be served and no change in fares is proposed.

The Commission finds that public convenience and necessity require the proposed service. The application will be granted. A public hearing is not necessary.

ORDER

IT IS ORDERED that:

- 1. Appendix A of Decision No. 65057, on Application No. 44905 of Airport Coach Service, a corporation, is hereby amended by incorporating therein First Revised Page 3 and First Revised Page 4, attached hereto and made a part hereof, in revision of Original Page 3 and Original Page 4.
- 2. Within sixty days after the effective date hereof and on not less than five days' notice to the Commission and to the public, applicant shall amend its tariffs and timetables, now on file with this Commission, to reflect the authority herein granted.

SECTION 2. ROUTE DESCRIPTIONS

Subject to the authority of this Commission to change or modify such at any time, Airport Coach Service shall conduct its passenger stage operations between the following points and over and along the following described routes:

*Newport Beach, Santa Ana, Orange, Anaheim (Disneyland), Buena Park

Commencing at the Newporter Inn, Jamboree Road and Pacific Coast Highway, Newport Beach; thence along Jamboree Road, Palisades Road, McArthur Boulevard, Main Street, Second Street, and Spurgeon Street to the Union Bus Depot, 220 East Third Street, Santa Ana; thence along Third Street and Main Street to Santa Ana-Orange, 32 Town and Country, Orange; thence along Main Street, Garden Grove Freeway, Santa Ana Freeway, Los Angeles Street, Katella Avenue, and West Street to the Disneyland Hotel, 1441 South West Street, Anaheim; thence (1) over and along the most direct or appropriate route or routes to the San Diego Freeway, thence along the San Diego Freeway and Century Boulevard to the Los Angeles International Airport, or (2) along West Street, Ball Road, Santa Ana Freeway and Manchester Avenue to Stage Stop Travel Agency, 6333 Manchester Avenue, Buena Park; thence over and along the most direct or appropriate route or routes to the Los Angeles International Airport, subject, however, to local traffic regulations.

Also, along the Santa Ana Freeway between the Garden Grove Freeway and Artesia Boulevard.

SECTION 2, Route Descriptions

*Newport Beach, Anaheim (Disneyland), Anaheim (Downtown), Fullerton, Buena Park

Commencing at the Newporter Inn, Jamboree Road and Pacific Coast Highway, Newport Beach, thence along Pacific Coast Highway, Newport Avenue, Harbor Boulevard, Katella Avenue and West Street to the Disneyland Hotel, 1441 South West Street, Anaheim; thence (1) over and along the most direct or appropriate route or routes to the San Diego Freeway, thence along the San Diego Freeway and Century Boulevard to the Los Angeles International Airport, or (2) along West Street, Ball Road and Los Angeles Street to the Pickwick Hotel, 225 South Los Angeles Street, Anaheim; thence along Los Angeles Street, Harbor Boulevard, Commonwealth Avenue, Malden Avenue, Whiting Avenue, Harbor Boulevard to the California Hotel, 305 South Harbor Boulevard, Fullerton; thence along Harbor Boulevard, Commonwealth Avenue, Beach Boulevard, and Manchester Avenue to the Stage Stop Travel Agency, 6333 Manchester Avenue, Buena Park; thence over and along the most direct or appropriate route or routes to the Los Angeles International Airport, subject, however, to local traffic regulations.

Shuttle Service

Supplementary shuttle service to connect with through service may be conducted between the Disneyland Hotel, on the one hand, and Newport Beach, Santa Ana, Orange, Anaheim, Fullerton or Buena Park, on the other hand, over any authorized route or combination of routes.
