O P I N I O N

La Salle Freight Company, a corporation, requests authority to sell and transfer and La Salle Trucking Company, a corporation, requests authority to purchase and acquire certain highway common carrier operative rights. Said rights were granted by Decision No. 61449, dated February 7, 1961, in Application No. 42731, as amended by Decision No. 61691, dated March 21, 1961, and authorize the transportation of general commodities, with certain exceptions, between the Los Angeles Basin Territory and the San Diego Drayage Area, on the one hand, and Tecate and an area within 30 miles of El Centro, on the other hand. The agreed cash consideration is \$2,024.87.

Applicant Buyer is presently engaged in the transportation of petroleum products as a highway common carrier. As of December 31, 1962, it indicated a net worth in the amount of \$419,239.

It is alleged that applicants Buyer and Seller have occupied the same premises and have shared overhead expenses in the past and that the acquisition of the rights herein considered by applicant Buyer can effect substantial economies and render to the public an over-all service with adequate facilities.

After consideration the Commission finds that the proposed transfer would not be adverse to the public interest. A public hearing is not necessary.

O R D E R

IT IS ORDERED that:

1. On or before December 1, 1963, La Salle Freight Company may sell and transfer, and La Salle Trucking Company may purchase and acquire, the operative rights referred to in the application.

2. Within thirty days after the consummation of the transfer herein authorized, La Salle Trucking Company shall notify the Commission, in writing, of that fact and within said period shall file with the Commission a true copy of any bill of sale or other instrument of transfer which may be executed to effect said transfer.

3. La Salle Trucking Company shall amend or reissue the tariffs on file with the Commission, naming rates, rules and regulations governing the common carrier operations herein to show that it has adopted or established, as its own, said rates, rules and regulations. The tariff filings shall be made effective not earlier than thirty days after the effective date of this order on not less than thirty days' notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the consummation of the transfer herein authorized. The tariff filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80-A.

The effective date of this order shall be twenty days after the date hereof.
