Applicant, presently rendering a passenger stage service within the City of Stockton and its environs, requests authority to reroute his operation between Caran Avenue and Lincoln Road, on the one hand, and, on the other hand, Pershing Avenue and Meadow Avenue. Service is now conducted via Caran Avenue and Meadow Avenue from Lincoln Road to Pershing Avenue. Instead he now proposes to operate via Lincoln Road and Pershing Avenue.

As justification it is alleged that this change will eliminate a dangerous operation along a narrow road without sidewalks, gutters or curbing. No additional mileage will be required and the public will, in no substantial degree, be adversely affected. The staff has made an inspection of this area and recommends granting the application. Copies of the application have been served in accordance with the Commission's procedural rules.

Upon consideration of the verified application and the staff recommendation, the Commission finds as follows:

1. Applicant possesses the experience, equipment, personnel and financial resources to institute and maintain the scrvice as proposed.

2. Public convenience and necessity require that the application be granted as set forth in the ensuing order.

3. Public hearing is not necessary.

IT IS ORDERED that:

1. A certificate of public convenience and necessity is hereby granted to Robert A. Burrowes authorizing the establishment and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers between the points and over the routes set forth in Second Revised Page 3 attached hereto, as an extension and enlargement of, consolidation with and subject to all the limitations and restrictions set forth in the certificate granted by Decision No. 61118, as amended.

2. Appendix A of Decision No. 61118, as amended, is hereby further amended by incorporating Second Revised Page 3 attached hereto, in revision of First Revised Page 3.

3. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- (b) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file in the Commission's office in triplicate tariffs and timetables satisfactory to the Commission.
- (c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.

 - (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98.
