OPINION AND ORDER

Application No. 45979 is, in effect, a joint petition by Meyers Water Co. and Angora Water Co. for a modification of Decision No. 60328, dated June 28, 1960, in Applications Nos. 41414, 41868 and 42036. All four proceedings are therefore consolidated for the purposes of the ensuing order.

Ordering paragraph 9 of Decision No. 60328 authorized the transfer from Angora to Meyers of a certificate of public convenience and necessity to construct a water system to serve a tract known as Christmas Valley, Unit No. 2, in El Dorado County. The authority was to have expired unless exercised on or before August 31, 1960. Despite nine extensions of time granted by this Commission, the transfer has not been effected. Applicants allege that the delay has been due to serious difficulties encountered in developing a well adequate to serve the tract, but that a suitable source now is available. Applicants request that Decision No. 60328 be modified to permit the transfer of the certificate on or before December 31, 1963.

The Commission finds that the modification of Decision No. 60328 requested by applicants would not be adverse to the public interest, and concludes that such modification should be made effective immediately.

IT IS ORDERED that:

1. Ordering paragraph 9 of Decision No. 60328 is modified to delete the date "August 31, 1960" therefrom and to substitute therefor the date December 31, 1963.

2. Except as modified hereinabove and in the order dated September 27, 1960, extending time for compliance with certain tariff filing requirements, Decision No. 60328 shall remain in full force and effect.

The effective date of this order shall be the date hereof.
