## OPINION

Evelyn M. Knapp and John P. Demeter, doing business as Peninsula Transit Lines, request authority to extend service over two proposed routes on a temporary basis.

Each route would originate at the Menlo Park Southern
Pacific Depot. One would extend to Alameda de Las Pulgas and
serve the west side of Menlo Park and the other would extend beyond
the Bayshore Freeway and serve the east side of Menlo Park.

It is alleged that the proposed extended service was requested by the City of Menlo Park; applicants have entered into an agreement with the City of Menlo Park whereby the City will pay to applicants any loss they suffer during the six-month period ending May 29, 1964; if at the end of six months there is a demonstrated need for the proposed service, applicants will provide the service on a permanent basis.

· A. 45971 After consideration, the Commission finds that public convenience and necessity require the granting of the application. Because the six-month period commences on December 2, 1963, the effective date of this order will be the date hereof. ORDER IT IS ORDERED that: 1. A certificate of public convenience and necessity is hereby granted to Evelyn M. Knapp and John F. Demeter, authorizing the establishment and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers between the points and over the routes set forth in Routes 16 and 17 as described in Third Revised Page 4, attached hereto, for a period of time ending May 29, 1964. 2. Appendix A of Decision No. 54368 is hereby amended by incorporating Third Revised Page 4 in revision of Second Revised Page 4. In providing service pursuant to the certificate herein granted, applicants shall comply with and observe the following service regulations: Within thirty days after the effective date hereof, applicants shall file a written acceptance of the certificate herein granted. (b) Within one hundred twenty days after the effective date hereof, applicants shall establish the service herein authorized and file in the Commission's office in triplicate tariffs and timetables satisfactory to the Commission. -2-

- (c) The tariff and timetable filings shall be made effective not earlier than one day after the effective date of this order on not less than one day's notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.
- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98.
