Uehling Water Co., Inc. (applicant) is a California corporation furnishing water to residential and commercial consumers in and around the City of Compton, Los Angeles County, California. As of August 31, 1963, it was furnishing service to 367 metered and 1,051 unmetered consumers.

Applicant is in the Central and West Basin Water Replenishment District and receives all of its water from wells therein. By Decision No. 62247, dated July 11, 1961, in Application No. 43272, it was authorized to increase its rates to offset said district's assessment. The rates authorized by that decision were subsequently increased to the present level pursuant to authority granted by Decision No. 64601, dated December 4, 1962, in Application No. 44515.

Several water companies pumping water from the Central Basin entered into a mutual agreement to reduce pumping from the basin. By Decisions Nos. 64308 and 65927, the latter dated August 27, 1963, both on Application No. 44616, applicant became a party thereto. It has had its entitlement to water from the basin established by the Department of Water Resources of the

State of California, acting as the Watermaster, at 677 acrefeet per year. It requires 877 acre-feet per year, which forces it to secure an additional 200 acre-feet per year. This water is secured from the Central Basin exchange pool at the presently effective rate of \$16.93 per year per acre-foot. In addition to this charge per acre-foot, applicant is required to pay a portion of the Watermaster's fees, amounting to \$54.31 per year, and it estimates the costs for preparation of this application at \$200. Applicant's present and proposed rates are as follows:

The staff witness report states that the increase will only offset the increase in expenses related to curtailment of pumping of wells in the Central Basin.

Upon consideration of the record, the Commission finds as follows:

1. Applicant's rates were established by Decision No. 64601, which allowed a rate of return of 7 percent. Since the date of said decision, applicant has been required to incur increased expenses due to curtailment of pumping rights and increased cost of excess water taken from the Central Basin.

2. The increase in rates proposed by the applicant will only offset the additional expenses arising from the increased cost of water.

3. A rate of return of 7.3 percent on the applicant's rate base of \$85,700 for the test year 1962 is reasonable and applicant should be authorized to file a new schedule of rates which should produce this rate of return.

4. The increased rates authorized herein are justified, the rates and charges authorized herein are reasonable and present rates, insofar as they differ from the rates authorized herein, are for the future unjust and unreasonable.


5. A public hearing is not necessary.

On the foregoing findings, we conclude that the application should be granted.
