BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the application of Dominic A. Mannino to operate 40 feet buses over certificated routes; operate passenger bus service between the City of Long Beach and Hollywood Park Race Track; Extend Anaheim - Santa Monica route; operate school bus service to Crestwood Elementary school and Bishop Montgomery High School.

Application No. 45995 (Filed December 3, 1963)

OPINION

Dominic A. Mannino, as a certificated passenger stage corporation, provides bus services to and from race tracks, sporting events, and aircraft plants; and for sight-seeing trips, as more specifically set forth in decisions heretofore issued by this Commission. Applicant is also a charter party carrier (Permit No. TCP-17).

By this application, authority is sought to provide service between points in the City of Long Beach and Hollywood Park Race Track during the harness racing season; to provide school bus service between the Rolling Hills Riveria housing development and the Crestwood School in San Pedro; to provide school bus service between the Bishop Montgomery Catholic High School in Torrance and Palos Verdes Estates; to alter and extend the existing route for transportation of passengers between Anaheim and the Douglas Aircraft Plant, and to extend service to the Douglas Aircraft Plant in Huntington Beach; and to operate oversized buses.

Race Track Service

The proposed service between Long Beach and Hollywood
Park Race Track in Inglewood, California, is to be confined to
the harness racing season only, and restricted to persons desiring
transportation on a round trip ticket basis. Pickups and discharges of passengers will be at designated points only in
Long Beach, and at the track. Round trip fares will be \$2.35.

Applicant alleges that this service has been rendered by Tanner Motor Tours, Ltd., and that during the 1963 harness racing season, said company abandoned this route and does not intend to provide service. He alleges that a substantial number of persons will use the proposed service, if authorized.

Aircraft Plant Service

Applicant now provides a service between Anaheim and the Santa Monica Douglas plant for transportation of the aircraft workers, via various city streets with no stops between Anaheim and Santa Monica. He proposes to reroute the Santa Monica plant service via the San Diego Freeway between Wardlow Road and Washington Boulevard. The rerouting will expedite the service.

Applicant also proposes to extend service to a new Douglas plant in Huntington Beach via the San Diego Freeway. He alleges that he has received numerous requests for transportation from the Santa Monica area to the Douglas plant in Huntington Beach, and that in the near future, many employees are to be transferred from the Santa Monica plant to the new plant. He requests authority to provide service to the new plant.

Passengers are to be picked up and discharged at designated points only in Culver City, Santa Monica and Huntington Beach. The proposed round trip fare is \$1.75 per person per day.

Crestwood School

Applicant requests authority to serve the Crestwood School in San Pedro from a housing development called the Rolling Hills Riviera. He is presently providing this service under contract with the Rolling Hills Home Owners Association, which association has requested that applicant deal directly with the parents and bill them rather than the association. This service is to be provided on school days only, with one 79-passenger school bus. A regular route is to be followed. The proposed fare is \$5.50 per month for the first child in a family and \$4.00 per month for each additional child.

Bishop Montgomery Catholic High School

Applicant requests authority to serve the Bishop Montgomery Catholic high school in Torrance from the Palos Verdes Estates and Torrance areas. This service is presently being provided under contract with a school bus transportation committee which has requested that applicant submit billing charges to the parents. Service is to be provided on school days only, with one 70-passenger school bus. A regular route is to be followed. The proposed fare will be \$10.00 per month per child.

Oversize Equipment

Applicant requests permission to operate 40-foot two axle buses as required, over certificated routes in both urban and suburban service. Specifically, applicant alleges that he

proposes to use 1956 Crown coaches equipped with glass tops, air conditioning, and seating 53 passengers in non-reclining sight-seeing-type seats. Applicant alleges that on numerous occasions he has found it necessary to operate two vehicles over certificated routes in order to accommodate passengers.

General

No additional equipment will be required. Applicant has total assets he values at \$313,335 and total liabilities of \$163,233. His current assets as of June 30, 1963, were \$58,777, and his current liabilities were \$64,283, including \$54,160 of equipment contracts payable in one year.

The competing carriers, the cities and communities involved, and the Division of Highways of the Department of Public Works of the State of California, were served with copies of the application. No protests or objections have been filed by any of said parties or entities.

Findings

The Commission having considered this matter finds that:

- 1. Applicant is a passenger stage corporation rendering service, as such, for the transportation of race-track patrons, airline passengers, special event patrons, school children to and from specified schools, and employees of specified manufacturing plants.
- 2. Applicant has the proper equipment with which to render his existing service and the service proposed herein.
- 3. Applicant has adequate finances with which to render his authorized services and any additional services proposed herein.

- 4. The proposed changes in existing routes are not adverse to the public interest, and public convenience and necessity require that applicant extend his service and inaugurate service as set forth in the order herein.
- 5. Public interest requires that applicant be permitted to operate passenger stage equipment not exceeding 40 feet in length and 102 inches in width.
 - The proposed fares are reasonable.
 A public hearing is not necessary.

Conclusion

From the foregoing findings the Commission concludes that the application should be granted.

ORDER

IT IS ORDERED that:

- 1. A certificate of public convenience and necessity be and it hereby is granted to Dominic A. Mannino authorizing him to establish and operate a service for the transportation of persons as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, between the points and over the routes more particularly set forth in Appendix A attached hereto and made a part hereof.
- 2. Appendix A to Decision No. 60045, as heretofore amended, is hereby further amended by incorporating therein the following pages which are attached hereto and made a part hereof:

- 3. Applicant is hereby authorized to operate passenger stage equipment not in excess of 40 feet in length and not to exceed 102 inches in width between the points and over the routes described in Decision No. 60045 as amended.
- 4. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:
 - Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that he will be required, among other things, to file annual reports of his operations and to comply with and observe the safety rules of the California Highway Patrol, the rules and other regulations of the Commission's General Order No. 98 and insurance requirements of the Commission's General Order No. 101-A. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Orders Nos. 98 and 101-A, may result in a carcellation of the operating authority granted by this decision.
 - (b) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file in the Commission's office in triplicate tariffs and timetables satisfactory to the Commission.
 - (c) The tariff and timetable filings shall be made effective not earlier than five days after the effective date of this order on not less than

five days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.

(d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98.

The effective date of this order shall be twenty days after the date hereof.
