ORDER REVOKING OPERATIVE AUTHORITY

It appearing that, by Decision No. 54202 dated December 4, 1956, in Application No. 38271, Henry L. Rubidoux was granted a passenger stage operative right authorizing service between Dunsmuir and Mt. Shasta, on the one hand, and Panther Meadows, on the other hand, and intermediate points; that, on March 14, 1961, by Decision No. 61673, Henry L. Rubidoux was authorized to suspend, for a period of one year, the passenger stage service theretofore conducted by him between Dunsmuir and Mt. Shasta and Panther Meadows pursuant to the foregoing described operative right; that, on April 24, 1962, by Decision No. 63606, the authority granted to Henry L. Rubidoux to suspend passenger stage service was extended to January 1, 1963; that, since March 16, 1961, Henry L. Rubidoux has had no evidence on file with this Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage, as required by General Order No. 101-A; and that Henry L. Rubidoux has not expressed his intention to resume service between the previously designated points; therefore,

IT IS ORDERED that the passenger stage operative rights, created by Decision No. 54202 in Application No. 38271, are hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Henry L. Rubidoux are hereby canceled.

The Secretary is directed to cause service of a certified copy of this order to be made upon Henry L. Rubidoux or to mail a certified copy thereof to Henry L. Rubidoux at 101 Pine Street, Dunsmuir, California, last known address as shown in the Commission's records.

The effective date of this order shall be the 30th day after such service upon Henry L. Rubidoux or after the above mailing to Henry L. Rubidoux, as the case may be, unless before such effective date there shall have been filed with this Commission written response to this order requesting public hearing in which event the effective date of this order shall be stayed until further order of the Commission.
