ORDER REVOKING OPERATIVE RIGHT

The certificate of public convenience and necessity granted to Fern Trucking Company, a corporation, has been suspended since July 31, 1963, for failure to have on file requisite evidence of liability insurance.¹ The carrier has not filed the required evidence of liability insurance since that date.

Fern Trucking Company has informed the Commission by letter that it wishes to abandon its certificate as it has gone out \checkmark of business and the corporation has been dissolved.

In the circumstances, it appears, and the Commission finds, that the revocation of the highway common carrier certificate as requested will not be adverse to the public interest. A public hearing is not necessary. The requested revocation will be granted and the tariffs applicable to service thereunder will be canceled.

IT IS ORDERED that:

1. The certificate of public convenience and necessity granted to Fern Trucking Company by Decision No. 54201 dated December 4, 1956, as amended by Decision No. 61535 dated February 21, 1961, in Application No. 37633 is hereby revoked.

2. Local Freight Tariff No. 1, Cal.P.U.C. No. 1, of Fern Trucking Company is hereby canceled.

3. T.A.L. Loretz, Agent, is hereby authorized and directed to cancel the participation of Fern Trucking Company from his Distance Table No. 4, Cal.P.U.C. No. 3, on file with this Commission, said cancellation to be made within ninety days after the effective date of this order and on not less than five days' notice to the Commission and the public.

The Secretary is directed to cause service of a certified copy of this order to be made upon Fern Trucking Company or to mail a certified copy thereof to it at its last known address as shown in the Commission's records, and to mail a copy of this order to T.A.L. Loretz, Agent.

The effective date of this order shall be the thirtieth day after such service upon Fern Trucking Company or after the above mailing to Fern Trucking Company, as the case may be, unless before such effective date there shall have been filed with this Commission a written request for a public hearing, in which event the effective date of this order shall be stayed until further order of the Commission.
