O P I N I O N

Bassco Drayage, Inc. requests that the following restriction be deleted from its certificated authority:

"Whenever Bassco Drayage, Inc. engages other carriers for (1) the transportation of property of Gordon H. Ball, Ball and Simpson, or Gordon H. Ball, Inc., Bassco Drayage, Inc. shall not pay such carriers less than 100% of the applicable minimum rates and charges established by the Commission for the transportation actually performed by such other carriers."

It is alleged that since the receipt of its certificated authority Gordon H. Ball, Florence A. Simpson, Executrix of the Estate of Millen L. Simpson, Deceased, and William D. Sorensen have sold their stock interests in Bassco Drayage, Inc. to John W. Ashford; by virtue of such sale and issuance of stock pursuant thereto, John W. Ashford is the sole owner of the applicant, and Gordon H. Ball and Ball and Simpson no longer have any direct or indirect interest in the company.

After consideration the Commission finds that the justification for the imposition of the restriction no longer exists. A public hearing is not necessary.

ORDER

IT IS ORDERED that Appendix A of Decision No. 66144 is hereby amended by substituting Second Revised Page 3 attached hereto in place of First Revised Page 3 and by deleting therefrom Original Page 4.

The effective date of this order shall be twenty days after the date hereof.

CONDITION:

Applicant shall transport no shipment subject to a minimum weight of 10,000 pounds or less or subject to a rate applicable to a shipment of 10,000 pounds or less to, from or between the following points:

- a. Points on U. S. Highway 50 between Placerville and the California-Nevada state line, inclusive.
- b. Points on State Highway 89 between U. S. Highways 40 and 50.
- c. Points on U. S. Highway 395 between Independence and the California-Nevada state line, inclusive.
