## SECOND SUPPLEMENTAL ORDER

By Decision No. 64509, dated November 7, 1962, in the above entitled proceeding, applicant, County of San Luis Obispo, was authorized to construct Price Canyon Road at separated grades over the track of Southern Pacific Company near Edna, San Luis Obispo County. The order provided that upon the completion of Price Canyon Road Overhead, Southern Pacific Company shall abolish Crossing No. E-258.2 (existing Price Canyon Road crossing), located approximately 0.2 mile westerly by physical closing and removal.

On July 10, 1963, the County of San Luis Obispo filed a petition to modify Decision No. 64509 so that the existing grade Crossing No. E-258.2 be closed to public use and travel instead of physically closed and removed. By Decision No. 66116, dated October 1, 1963, the First Supplemental Order authorized the modification.

On December 26, 1963, the Southern Pacific Company filed a petition for modification of Decision No. 64509 and Decision No. 66116 to provide that the existing at grade crossing revert to a private crossing only if it be maintained and used on terms agreed to by the Southern Pacific Company and the owner of the parcel of land abutting the railroad right of way at said crossing. By letter of January 27, 1964, the County of San Luis Obispo interposed no objection to the second petition for modification. This request has

been investigated by the Commission staff and it is recommended that the second petition for modification be granted.

Good cause appearing, IT IS ORDERED that the second paragraph of Decision No. 64509 which was changed by Decision No. 66116, be revised to read as follows: "Upon completion of Price Canyon Road Overhead, Southern Pacific Company shall close Crossing No. E-258.2 (existing Price Canyon Road Crossing), located approximately 0.2 mile westerly, to public use and travel. This crossing shall revert to a private crossing to be maintained and used on terms agreed to by the Southern Pacific Company and the owner of the parcel of land abutting the railroad right of way at said crossing."

In all other respects Decision No. 64509 and Decision No. 66116 shall remain in full force and effect.
