Application of SAN DIEGO TRANSIT SYSTEM, a Corporation, for authority to revise certain of its school routes.

Application No. 46810 (Filed July 15, 1964)

OPINION AND ORDER

By this application San Diego Transit System, a corporation, requests authority to make changes in the operation of its school routes to meet the needs of the students and to conform with local traffic requirements.

The San Diego Unified School District has informed this Commission that it has no objection to the proposed route changes. The Commission's staff reports that the re-routing of Routes Nos. 21 to 26, inclusive, and Routes Nos. 31, 32, 35, 39, 40 and 41 are necessary due to the construction of new schools and changes in traffic patterns.

No change in fares is contemplated and the matter is not controversial.

The Commission having considered the application finds that public convenience and necessity require that the routes hereinabove mentioned be re-routed as set forth in the appendix to this decision.

IT IS ORDERED that:

- 1. A certificate of public convenience and necessity is hereby granted to San Diego Transit System, a corporation, authorizing the establishment and operation of service as a "passenger stage corporation", as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers between the points and over the routes set forth in Sixth Revised Page 3, Fourth Revised Page 34, Fourth Revised Page 35, Fourth Revised Page 36, First Revised Page 37, Third Revised Page 38, Third Revised Page 39, Third Revised Page 44, Fourth Revised Page 45, Third Revised Page 48, Third Revised Page 52, Third Revised Page 53, and Second Revised Page 54, attached hereto, as an extension and enlargement of, consolidation with and subject to all the limitations and restrictions set forth in the certificate granted by Decision No. 55090, as amended.
- 2. Appendix A of Decision No. 55090, as amended, is hereby further amended by incorporating therein the above-revised pages, attached hereto, in revision of Fifth Revised Page 3, Third Revised Page 34, Third Revised Page 35, Third Revised Page 36, Original Page 37, Second Revised Page 38, Second Revised Page 39, Second Revised Page 44, Third Revised Page 45, Second Revised Page 48, Second Revised Page 52, Second Revised Page 53, and First Revised Page 54.
- 3. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- (b) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file tariffs and timetables, in triplicate, in the Commission's office.
- (c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.
- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98.
