SUPPLEMENTAL OPINION AND ORDER

By Decision No. <u>67850</u>, entered today in Cases Nos. 5432 and 5441, amendments in City Carriers' Tariff No. 1-A and Minimum Rate Tariffs Nos. 1-B and 2 were authorized to correct erroneous references pertaining to charges for special handling services in connection with pool car shipments.

In order to avoid duplication of tariff distribution, the aforesaid decision also authorized amendment of Minimum Rate Tariff No. 1-B by separate order.

IT IS ORDERED that:

1. Minimum Rate Tariff No. 1-B (Appendix B of Decision No. 65834, as amended) is hereby further amended by incorporating therein, to become effective October 24, 1964, Third Revised Page 27 attached hereto and by this reference made a part hereof.

2. Tariff publications required to be made by common carriers as a result of the order herein may be made effective not earlier than the tenth day after the effective date of this order on not less than ten days' notice to the Commission and to the public and such tariff publications shall be made not later than October 24, 1964.

3. Common carriers, in establishing and maintaining the rates authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the rates published under this authority shall make reference to the prior orders authorizing longand short-haul departures and to this order.

4. In all other respects said Decision No. 65834, as amended, shall remain in full force and effect.

This order shall become effective twenty days after the date hereof.
