## SUPPLEMENTAL OPINION AND ORDER

67974 By Decision No. entered today in Case No. 5432, et al., the Commission found that "disaster supplies" should be exempted from the minimum rates.

The aforesaid decision also found that in order to avoid duplication of tariff distribution, Minimum Rate Tariff No. 6-A should be amended by separate order.

IT IS ORDERED that Minimum Rate Tariff No: 6-A (Appendix A to Decision No. 67154, as amended) is further amended by incorporating therein, to become effective November 14, 1964 First Revised Page 7 attached hereto and by this reference made a port hereof.

In all other respects, said Decision No. 67154, as amended, shall remain in full force and effect.

## MINIMUM RATE TARIFF NO. 6-A

SECTION NO. 1 - RULES AND REGULATIONS (Continued)	Item No.
DEFINITION OF TECHNICAL TERMS (Concluded) (Items Nos. 10 and 11)	
RAILHEAD means a point at which facilities are maintained for the loading of property into or upon, or the unloading of property from, rail cars or vessels. It also includes truck loading facilities of plants or industries located at such rail or vessel loading or unloading point.	
RATE includes charge and, also, the ratings, minimum weight, rules and regulations governing, and the accessorial charges applying in connection therewith.	
SAME TRANSPORTATION means transportation of the same kind and quantity of property and subject to the same limita- tions, conditions and privileges, although not necessarily in an identical type of equipment.	
SHIPMENT means a quantity of freight tendered by one shipper on one shipping document at one point of origin at one time for one consignee at one point of destination. (See Items Nos. 220 and 230 for exceptions.)	
SPLIT DELIVERY SHIPMINT means a shipment consisting of two or more component parts delivered to (a) one consignee at more than one point of destination, or (b) more than one consignee at one or more points of destination, said shipment being shipped by one consignor at one point of origin and charges thereon being peid by the consignor when there is more than one consignee.	11
TEAM TRACK means a point at which property may be loaded into, or upon, or unloaded from reil cars by the public generally. It also includes wherves, docks and landings at which the public generally may receive and tender shipments of property from and to common carriers by vessel.	
UNLOADING TIME means that time which commences when car- rier's equipment is placed in position to unload and/or spread and which terminates when carrier's equipment is released for departure from point of destination. It also includes time spent in weighing, sampling and/or the pro- cossing of samples even though such time may be spent prior to the placement of the equipment in position to unload or spread.	
APPLICATION OF TARIFF - GENERAL	
Rates provided in this tariff apply for the transporta- tion of chipments of petroleum and petroleum products as described in Item No. 30, in bulk in tank trucks, tank trailers or tank semitrailers, or a combination of such highway vehicles, between points in the State of California by petroleum contract carriers as defined in the Highway Carriers' Act, and by carriers as defined in the City Car- riers' Act. Rates include connecting and disconnecting piping and other services incidental to loading and unload- ing except those services for which rates or charges are provided in individual items.	ø20

For rates for the transportation of petroleum and petroleum products, other than as provided in this tariff, see Minimum Rate Tariff No. 2.

Rates, rules and regulations named in this tariff shall not apply to transportation by independent-contractor subhaulers when such transportation is performed for other carriers. This exception shall not be construed to exempt from the tariff provisions carriers for whom the independent contractors are performing transportation service.

øRates in this tariff do not apply to the transportation of:

(a) Property of the United States or property transported under an agreement whereby the United States contracted for the carrier's services.

\*(b) Disaster Supplies, i.e., those commodities which are allocated to provide relief during a state of extreme emergency or state of disaster; and those commodities which are transported for a civil defense or disaster organization established and functioning in accordance with the California Disaster Act to ultimate point of storage or use prior to or during a state of disaster or state of extreme emergency.
