SUPPLEMENTAL OPINION AND ORDER

Decision No. 64802, dated January 15, 1963 (60 Cal.P.U.C. 453), as amended, found that Distance Table No. 5 should be adopted as the constructive miles, with governing rules, to be used in connection with the minimum rate tariffs issued by the Commission. The application of Distance Table No. 5 to the various tariffs was deferred until separate proceedings were held for each minimum rate tariff.

Distance Table No. 5 has been made applicable to all of the Commission tariffs containing distance rates as indicated below:

- 1. Minimum Rate Tariff No. 2 (general commodities), effective November 1, 1964. (Decision No. 67531 dated July 14, 1964, as amended by Decision No. 67703 dated August 11, 1964, in Case No. 5432.)
- 2. Minimum Rate Tariff No. 3-A (livestock), effective March 21, 1964. (Decision No. 66788 dated February 11, 1964, in Case No. 5433.)
- 3. Minimum Rate Tariff No. 4-B (household goods), effective November 1, 1964. (Decision No. 67900 dated September 22, 1964.)
- 4. Minimum Rate Tariff No. 6-A (petroleum), effective November 1, 1964. (Decision No. 67902 dated September 22, 1964.)

- 5. Minimum Rate Tariff No. 8 (fruits and vegetables), effective November 1, 1964. (Decision No. 67849 dated September 15, 1964, in Case No. 5438.)
- 6. Minimum Rate Tariff No. 10 (cement and related commodities), effective October 1, 1964. (Decision No. 67123 dated April 21, 1964, as amended by Decision No. 67404 dated June 16, 1964, in Case No. 5440.)
- 7. Minimum Rate Tariff No. 11-A (uncrated new furniture), effective July 18, 1964. (Decision No. 67364 dated June 10, 1964, in Case No. 5603.)
- 8. Minimum Rate Tariff No. 12 (motor vehicles and related items), effective August 29, 1964. (Decision No. 67566 dated July 21, 1964, in Case No. 5604.)
- 9. Minimum Rate Tariff No. 14 (hay and related commodities), effective February 22, 1964. (Decision No. 66625 dated January 14, 1964, in Case No. 5432.)

In the circumstances, Distance Table No. 4 will be canceled since it is no longer applicable to any Commission tariff. A public hearing is not necessary.

IT IS ORDERED that Distance Table No. 4 is hereby canceled by incorporating therein to become effective November 1, 1964, Supplement No. 13 attached hereto and by this reference made a part hereof.

The effective date of this order shall be November 1, 1964.
