OPINION

Union Ice & Storage Company requests authority to discontinue cold storage warehouse operations at Hayward.

Applicant's operating authority is prescriptive in nature and was described in Case No. 6533, dated June 14, 1960. The authorized area is 7,875 square feet of warehouse space.

It is alleged that during recent years applicant's number of storers has dwindled to the point where applicant has only one customer who desires to rent all of said plant directly from applicant's landlord.

After consideration the Commission finds that the granting of the application would not be adverse to the public interest.

A public hearing is not necessary.

ORDER

IT IS ORDERED that:

1. Union Ice & Storage Company is hereby authorized to discontinue public utility warehouse operations at Hayward.

- 2. Within one hundred twenty days after the effective date hereof and on not less than five days' notice to the Commission and to the public, Union Ice & Storage Company shall amend its tariffs presently on file with the Commission to reflect the authority herein granted.
- 3. Concurrently with the effective date of tariff filings required by ordering paragraph 2 hereof, the prescriptive operative right set forth in Appendix A of Decision No. 66841, dated February 25, 1964, in Application No. 46144, is hereby revoked and, in place and stead thereof, a prescriptive operative right as a public utility warehouseman is hereby stated for Union Ice & Storage Company as more particularly set forth in Appendix A attached hereto.

The effective date of this order shall be twenty days after the date hereof.
