SUPPLEMENTAL OPINION AND ORDER

By Decision No. 67326 dated June 3, 1964, in Case No. 5432, Petition for Modification No. 341, Charles E. Zimmerman was authorized to transport shipments of wholesale drug supplies, each weighing 75 pounds or less, for Western Drug Supply and McKesson-Robbins, Inc., between Sacramento and Isleton via Courtland and Walnut Grove at charges per shipment less than the established minimum charges otherwise applicable.

By this petition, authority is sought to transport shipments of wholesale drug supplies for Brunswig Drug Company between the same points at the same less-than-minimum charges per shipment subject to the same limitations and conditions authorized by Decision No. 67326, supra.

Petitioner avers that, through oversight, he failed to include in Petition for Modification No. 341 the firm of Brunswig Drug Company, a wholesale drug supply business in ... Sacramento, as a shipper and that such failure has subjected this shipper to a discriminatory disadvantage in competing with McKesson-Robbins, Inc. and Western Drug Supply in making sales to drug stores in Courtland, Walnut Grove and Isleton. Petitioner further avers that the needs of Brunswig Drug Company in regard to shipping are identical with those of McKesson-Robbins, Inc. and Western Drug Supply.

The petition shows that a copy thereof was served upon California Trucking Association on or about November 17, 1964. No objection to the granting of the petition has been received.

In the circumstances, it appears, and the Commission finds, that Decision No. 67326, supra, should be amended as provided in the following order. A public hearing is not necessary. The petition should be granted.

IT IS ORDERED that:

- 1. Ordering Paragraph 2 of Decision No. 67326 dated

 June 3, 1964, in Case No. 5432 is hereby amended to read as follows:
- 2. Charles E. Zimmerman is hereby authorized to transport shipments of wholesale drug supplies, each weighing 75 pounds or less, for Western Drug Supply, McKesson-Robbins, Inc., and Brunswig Drug Company between Sacramento and Isleton via Courtland and Calnut Grove, at charges per shipment less than the established minimum charges per shipment but not less than the following:

3. In all other respects, said Decision No. 67326 shall remain in full force and effect.
