SUPPLEMENTAL OPINION AND ORDER

Decision No. 65745 dated July 23, 1963, in this proceeding authorized Virginia Benini to acquire an operative right to transport passengers by motor vehicle within the City of San Bernardino and between San Bernardino and adjacent areas. It has come to the Commission's attention that Decision No. 65745, supra, is not clear with respect to the fare structure authorized for the operations involved. The necessary clarification should be made.

IT IS ORDERED that:

1. Ordering Paragraph 3 of Decision No. 65745 dated July 23, 1963, is amended to read as follows:

> "3. On or before May 1, 1965, applicant purchaser shall amend or reissue the tariffs on file with the Commission naming rates, rules, and regulations governing the common carrier operations herein to show that applicant seller has withdrawn or canceled and applicant purchaser has adopted or established, as her own, said rates, rules and regulations. The tariff shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public. The tariff and timetable filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98."

2. Decision No. 65745 dated July 23, 1963, is further amended by adding thereto Ordering Paragraph 6 to read as follows:

> "6. Applicant purchaser may, in complying with the provisions of amended Ordering Paragraph 3 hereof, publish the passenger fares authorized by Decision No. 60737 dated September 13, 1960, in Application No. 42526, except that a 12-ride 2-zone school children fare of \$1.32 and a 12-ride 3-zone school children fare of \$1.44 shall be substituted for the ll-ride 2-zone school children fare of \$1.21 and the ll-ride 3-zone school children fare of \$1.32 respectively."

3. In all other respects, Decision No. 65745 shall remain in full force and effect.

This order shall become effective twenty days after the date hereof.
