## INTERIM ORDER ALLOWING INSPECTION OF CERTAIN RECORDS

Aldercroft Eeights County Water District having filed herein a verified request for inspection and reproduction of records, and good cause appearing,

IT IS CRDERED that Aldercroft Heights Company, a corporation, within fifteen days from the date hereof shall make available to Aldercroft Heights County Water District and its counsel, Robert Francis Jacobs, for the purpose of inspection and reproduction only, the following records of Aldercroft Heights Company:

- 1. All records of the dollar amounts of gross additions, betterments, and retirements to operative utility properties of Aldercroft Heights Company subsequent to October 24, 1961, together with a description thereof.
- 2. All other records, statements, receipts and invoices relating to such additions, betterments, and retirements.

IT IS FURTHER ORDERED that such inspection of records shall be at the offices of Robert Francis Jacobs, 510 Community Bank Building, San Jose, California; that an officer of said

Aldercroft Heights Company, or its counsel, E. William Grischy, may be present at all times during such inspection, and that such inspection and the reproduction of any of such records shall be accomplished promptly and with as little inconvenience to Aldercroft Heights Company and its representatives as may be possible under the circumstances. Such inspection and reproduction of records shall not consume more than three days.

IT IS FURTHER ORDERED that upon completion of such inspection and reproduction of records one copy of each record reproduced shall be furnished to Aldercroft Heights Company or its counsel and one copy thereof to the Commission. Aldercroft Heights County Water District and its counsel are hereby directed to return all records so inspected or reproduced to Aldercroft Heights Company or its counsel immediately upon completion of such inspection and reproduction, and to advise the Commission, in writing, immediately on such return, of the date or dates such records were in their possession and of the date on which said records were returned to Aldercroft Heights Company or its counsel. A receipt of such records, signed by an officer of or counsel for Aldercroft Heights Company, to be transmitted to the Commission with such advice letter. will be considered satisfactory proof that said records have been returned by Aldercroft Heights County Water District to Aldercroft Heights Company, as herein directed.

The Secretary of the Commission is directed to cause personal service of a certified copy of this interim order to be

made upon Aldercroft Heights Company, a corporation, and upon Aldercroft Heights County Water District, a public district, in the manner provided by law.

The effective date of this order shall be the date hereof.
