SUPPLEMENTAL OPINION AND ORDER

Decision No. 68822 dated March 30, 1965, in Case No. 5330 (Petition for Modification No. 26), suspended the effective date of the tariff pages covered by Decision No. 68306 dated November 30, 1964, in Case No. 5330 (Order Setting Hearing dated February 11, 1964) and reopened the latter proceeding for further hearing.
