OPINION AND ORDER

Applicant holds radial highway common carrier, highway contract carrier and city carrier permits.¹ By Decision No. 67289 dated May 26, 1964, in Application No. 46488, applicant was authorized to transport brandy, in barrels, for Fromm & Sichel, Inc., between Lac Jac, on the one hand, and Biola, Fowler, Monmouth and Mission Bell, on the other hand, at rates less than the established minimum rates. The current authority is scheduled to expire with June 17, 1965.

By this application, authority is sought to continue the deviation from the established minimum rates for a further one-year period. Applicant also requests that the authority be modified by decreasing the authorized rates between Lac Jac, on the one hand, and Biola and Monmouth, on the other hand, by one cent.

Applicant alleges that all of the beneficial transportation characteristics recited in previous applications still exist and that

its increase in gross revenue, together with further economies achieved in handling, particularly loading and unloading procedures, has resulted in greater profits despite nominal increased costs.

Data furnished by applicant indicate that the transportation involved has been profitable and reasonably may be expected to be profitable in the future.

Applicant declares that the record in prior proceedings has indicated that the shipper, Fromm & Sichel, Inc., is prepared to engage in proprietary operations, should the need arise, and has the necessary facilities to do so. Applicant asserts that continuation of the authority sought herein is essential in order that it may retain the shipper's traffic.

The certificate of service shows that a copy of the application was mailed to various parties believed to be interested, including California Trucking Association. No objection to the granting of the application has been received.

In the circumstances, it appears, and the Commission finds, that the proposed rates are reasonable. A public hearing is not necessary. The application should be granted.

In view of the impending expiration date of the current authority, the order which follows will be made effective June 17, 1965.

IT IS ORDERED that:

1. Harry McKenzie Trucking Co., a corporation, is hereby authorized to transport brandy, in barrels, between Lac Jac, on the one hand, and Biola, Fowler, Monmouth and Mission Bell, on the other hand, for Fromm & Sichel, Inc., at rates less than the established

minimum rates but not less than the following, subject to a minimum weight of 40,000 pounds per shipment:

2. The authority herein granted shall, on and after June 17, 1965, supersede the authority granted by Decision No. 67289, and shall expire with June 17, 1966.

This order shall become effective June 17, 1965.
