Greyhound Lines, Inc. requests authority to redescribe, revise, revoke and redosignate specified routes in Route Group 12, including the establishment of new routes over (a) a relocated segment of U.S. Highway 99 between North Modesto Junction and South Modesto Junction and (b) over unnumbered highway between Davis Street Interchange and Hayward.

It is alleged that Highway 99 has been in the process of reconstruction and relocation, including a segment of approximately five miles in distance between North Modesto Junction and South Modesto Junction, which was expected to be ready for public use on or about June 23, 1965; that said route will be used by through buses and present schedules servicing Modesto will use access highways to the freeway; and that applicant proposes to use Davis Street for the operation of its San Francisco to Los Angeles express service serving San Leandro.

After consideration, the Commission finds that public convenience and necessity require the granting of the application. A public hearing is not necessary.

ORDER

IT IS ORDERED that:

1. A certificate of public convenience and necessity is hereby granted to Greyhound Lines, Enc., authorizing the establishment and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers, baggage and express between the points and over the routes set forth in Third Revised Page 13, First Revised Page 14, Fourth Revised Page 27, Second Revised Page 28, Third Revised Page 29, Third Revised Page 31-A, Third Revised Page 31-B, Second Revised Page 65, Second Revised Page 72 and First Revised Page 75 attached hereto, as an extension and enlargement of and consolidation with, and subject to all the limitations and restrictions set forth in, the certificate granted by Decision No. 55893 and in particular subject to the provisions set forth in Section 3 of Appendix A thereof.

3. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- (b) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file tariffs and timetables, in triplicate, in the Commission's office.
- (c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.
- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98.


