In the matter of the application of TANNER MOTOR TOURS, LTD. for the cancellation of Certificate of Public Convenience and Necessity to conduct passenger stage service and miscellaneous services in Palm Springs.

OPINION

A public hearing on the above application was held before Examiner Rogers in Palm Springs on June 21, 1965.

Decision No. 61751, dated March 28, 1961, in Application No. 42447, granted applicant an in lieu certificate of public convenience and necessity as a passenger stage corporation. Included in its authorities set forth in said decision are local service in the City of Palm Springs, service between the City and Southern Pacific Company rail station at Whitewater, and service to and from the Palm Springs Municipal Airport. By the application herein, it requests authority to abandon such services.

As the basis for such request, it alleges that on April 2, 1965, the City of Palm Springs informed the applicant by letter

that all applicant's existing franchises issued by the City were to be cancelled effective September 25, 1965.

Applicant has authority from this Commission to render passenger stage service within the City of Palm Springs and between the City and unincorporated areas in the vicinity as well as various services throughout Southern California. Its City of Palm Springs operations are subject to the regulation and supervision of this Commission (Asbury Rapid Transit System vs. the Railroad Commission, 18 Cal. (2d) 105.)

The applicant presented evidence that it consistently loses money on the city bus service and that there is little demand for service to and from the Southern Pacific Company station at Whitewater and for service to and from the Palm Springs Municipal Airport. It requests that these authorities be cancelled. There was no opposition to such requests.

The Commission finds that:

- 1. Applicant provides passenger stage service between points in the City of Palm Springs, including the municipal airport, and service between the City and the Southern Pacific Company station at Whitewater outside the city limits.
- 2. Applicant is consistently losing money in its intracity passenger stage operations in the City of Palm Springs. There is a lack of demand for services between the City of Palm Springs and/or the Southern Pacific Company station at Whitewater and/or the Palm Springs Municipal Airport.

A. 47518 - BR/AB* Neither public convenience nor public necessity requires that the Palm Springs intracity services of applicant, the service to the Southern Pacific Company station, or service to the Municipal Airport be continued; the discontinuance of such services will not be adverse to the public interest. The Commission concludes that the application should be granted. ORDER IT IS ORDERED that: Tanner Motor Tours, Ltd. may discontinue and abandon the following services in and around the City of Palm Springs, California, effective concurrently with the effective date of tariff filings required by paragraph 2 hereof: (a) Local passenger stage service in the City of Palm Springs. (b) Passenger stage service between the City of Palm Springs and the Southern Pacific Company station at Whitewater. (c) Passenger stage service to and from the Palm Springs Municipal Airport. Within one hundred twenty days after the effective date hereof and not less than fifteen days prior to the discontinuance of services authorized in paragraph I hereof, applicant shall publish notice of discontinuance of service pursuant to the authority herein granted for 10 days in a newspaper of general circulation in the City of Palm Springs and file a copy thereof with this Commission within 5 days after completion of publication. Applicant shall also amend its tariffs and timetables to reflect the authority herein granted not earlier than fifteen days after the effective date of this order, on not less than fifteen days' notice to the Commission and the public. -3-
