ORDER REVOKING OPERATIVE AUTHORITY

It appearing that, by Decision No. 58514 dated May 22, 1959, in Application No. 40747, Beninger Transportation Service, Inc. was authorized to operate a passenger stage service in Richmond and adjacent areas; that by Decision No. 62253 dated July 11, 1961, in Application No. 43357, Beninger Transportation Service, Inc. was authorized to sell all of its routes except Route No. 1 and as to Route No. 1 it was authorized to suspend service for a period of one year, which suspension was further extended by order dated March 31, 1964 until May 1, 1965; that, since November 8, 1961, Beninger Transportation Service, Inc. has had no evidence on file with this Commission showing protection against liability imposed by law for payment of damage for personal injury or property damage as required by General Order No. 101-A; and that Beninger Transportation Service, Inc. has not restored the service on Route No. 1 after May 1, 1965;

IT IS ORDERED that the passenger stage operative rights, for Route No. 1, created by Decision No. 58514 in Application No. 40747, are hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Beninger Transportation Service, Inc. are hereby canceled.
