SUPPLEMENTAL OPINION AND ORDER

By Decision No. 69469 dated July 27, 1965, in the above proceedings, certain zone rates in Minimum Rate Tariff No. 7 were modified and transferred to Minimum Rate Tariff 17. It has come to the Commission's attention that the application of Minimum Rate Tariff No. 7 does not clearly reflect the modification of such rates. The necessary clarification will be made by the order herein.

IT IS ORDERED that:

1. Minimum Rate Tariff No. 7 (Appendix "A" of Decision No. 32566, as amended) is hereby further amended by incorporating therein, to become effective January 1, 1966, Fourteenth Revised Page 4 attached hereto and by this reference made a part hereof.
2. In all other respects Decision No. 32566, as amended, shall remain in full force and effect.

This order shall become effective twenty days after the date hereof.

They apply for transportation of property by radial highway common carriers and highway contract carriers, as defined in said Highway Carriers' Act, and by carriers as defined in said City Carriers' Act, in bulk in dump truck equipment.</p> <p>The rates and rules contained in this tariff shall apply to transportation by underlying carriers (independent-contractor subhaulers) when such transportation is performed for other carriers, as provided in Item No. 94.</p>
ø25	<p style="text-align: center;">APPLICATION OF TARIFF - GENERAL</p> <p>Rates in this tariff do not apply to the transportation of:</p> <p>(a) Property of the United States or property transported under an agreement whereby the United States contracted for the carrier's services.</p> <p>(b) Disaster Supplies, i.e., those commodities which are allocated to provide relief during a state of extreme emergency or state of disaster; and those commodities which are transported for a civil defense or disaster organization established and functioning in accordance with the California Disaster Act to ultimate point of storage or use prior to or during a state of disaster or state of extreme emergency.</p> <p>*(c) Property for which rates are provided in Minimum Rate Tariff 17.</p> <p>For rates for the transportation of commodities in dump truck equipment, other than as provided in this tariff, see City Carriers' Tariff No. 1-A, Minimum Rate Tariff No. 1-B, 2, 5, 9-B or 17, as the case may be.</p>
