<u>OPINION</u>

Interamerican Warehouse Corporation requests authority to increase space in the City of Commerce from 102,000 square feet of floor space to 250,000 square feet.

Applicant presently occupies approximately 150,000 square feet of space located at 6277 East Slauson Avenue in the City of Commerce. The building is single story, contains approximately 250,000 square feet and is equipped with a sprinkler system. The additional space will be provided in the building or in the alternative, through the construction of an additional building.

It is alleged that the additional space is required in order to accommodate present storers who require additional space due to increases in production and sales in the Southern California area and to accommodate new accounts who are contemplating changes in warehouse and distribution methods from privately owned warehouses to public warehouses.

A copy of the application was served upon the Los Angeles Warehousemen's Association. The application was listed on the Commission's Daily Calendar of October 6, 1965. No protest has been received.

After consideration the Commission finds that public convenience and necessity require the granting of the application. A public hearing is not necessary.

ORDER

IT IS ORDERED that:

- 1. A certificate of public convenience and necessity is granted to Interamerican Warehouse Corporation, a corporation, as a public utility warehouseman, as defined in Section 239(b) of the Public Utilities Code, for the operation of storage or warehouse floor space as set forth in Appendix A attached hereto and made a part hereof.
- 2. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:
 - (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that it will be required, among other things, to file annual reports of its operations. Failure to file such reports, in such form and at such time as the Commission may direct, may result in a cancellation of the public utility warehouse operations authorized by this decision.
 - (b) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file tariffs, in triplicate, in the Commission's office.
 - (c) The tariff filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the establishment of the service herein authorized.
 - (d) The tariff filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 61-A.

3. Concurrent with the tariff filings required by ordering paragraph 2(b) hereof, the operating authority granted in Case No. 6725, dated August 1, 1960, is hereby revoked.

The effective date of this order shall be twenty days after the date hereof.
