In the Matter of the Application of SAN MIGUEL TELEPHONE CO. and SAN MIGUEL TELEPHONE COMPANY OF CALIFORNIA for an order authorizing: (a) SAN MIGUEL TELEPHONE CO., a corporation, to sell and transfer and SAN MIGUEL TELEPHONE COMPANY OF CALIFORNIA, a corporation, to purchase and acquire the telephone properties, plant and system owned by SAN MIGUEL TELEPHONE CO.; (b) SAN MIGUEL TELEPHONE CO. to withdraw from the public utilities business; (c) SAN MIGUEL TELEPHONE COMPANY OF CALIFORNIA, a corporation, to engage in the public utility business now being conducted by SAN MIGUEL TELEPHONE CO.; (d) the issuance of shares of the capital stock of SAN MIGUEL TELEPHONE CO.; (d) the assumption of the liabilities of SAN MIGUEL TELEPHONE CO. by SAN MIGUEL TELEPHONE CO. by SAN MIGUEL TELEPHONE COMPANY OF CALIFORNIA; (e) SAN MIGUEL TELEPHONE COMPANY OF CALIFORNIA; (e) SAN MIGUEL TELEPHONE COMPANY OF CALIFORNIA; (e) SAN MIGUEL TELEPHONE COMPANY OF CALIFORNIA; to borrow \$597,000.00.

OPINION AND ORDER

The petition of San Miguel Telephone Company of California shows that by the terms of Decision No. 68384 issued in this matter on December 22, 1964, petitioner was authorized to borrow certain monies "on substantially the terms and conditions and in the manner set forth in Exhibits D, E and F attached to the application". Said Exhibit F was a form of mortgage note in general use at the time. A different form of mortgage note is now used and petitioner seeks modification of Decision No. 68384 in order to permit it to accept and execute the new form of mortgage note.

The Commission finds that the new mortgage note, attached to the petition herein as Exhibit F-1, is in fact substantially the same as that heretofore authorized for execution and that public hearing with respect thereto is unnecessary. It is concluded that the petition should be granted.

IT IS ORDERED that petitioner be and it is hereby authorized to execute and issue mortgage notes in substantially the form of Exhibit F-1 attached to the petition herein.
