OPINION AND ORDER

California Cities Water Company, successor, by Decision No. 68242, dated November 24, 1964, to San Dimas-Charter Oak Domestic Water Company, seeks authority to extend water service to Tract No. 22188, comprising 13 lots in San Dimas in the area shown in red on the map, Exhibit A, attached to the application. Except for the restrictions imposed on applicant's predecessor by Decision No. 66739 and reaffirmed by Decisions Nos. 67648 and 68495, applicant could, pursuant to Section 1001 of the Public Utilities Code, extend its service as requested herein without authority of the Commission.

A report of the results of his investigation of the application, dated October 21, 1965, has been submitted by a Commission staff engineer, and it is received as Exhibit No. 1. Said exhibit shows that no objection has been entered to the granting of the application; that applicant's water supply and facilities are adequate and meet the requirements of General A. 47877

Order No. 103; and contains a recommendation that the application be granted.

The Commission finds that:

1. Public hearing is not necessary.

2. There is a public demand for water service to the 13 lots comprising Tract No. 22188 in San Dimas.

3. Public convenience and necessity require that the restrictions against applicant extending its water system outside its certificated boundaries imposed by Decision No. 66739 be lifted and that applicant be granted a certificate of public convenience and necessity to extend its water system to and furnish water service in Tract No. 22188.

It is concluded that the public interest requires that the application be granted, therefore,

IT IS ORDERED that:

1. The restrictions against California Cities Water Company extending its water service outside of the boundaries of the area, as imposed by Decision No. 66739, are lifted to the extent that a certificate of public convenience and necessity is granted to California Cities Water Company to extend its water system and operate a public utility water system in Tract No. 22188 in the City of San Dimas as shown on the map, Exhibit A, attached to the application.

2. Within one year after the effective date of this order, applicant may file revised tariff sheets, including a revised tariff service area map, to provide for the application of its present San Dimas tariff schedule to the tract certificated herein.

Such filing shall be in conformity with General Order No. 96-A and the revised tariff sheets shall become effective the fourth day after the date filed.

3. Except for the authorization herein granted, the restrictions against extension of service imposed by the order in Decision No. 66739 shall remain in full force and effect.

4. Within sixty days after the effective date of the order in this proceeding, applicant shall file with the Commission two copies of a comprehensive map, or maps, drawn to an indicated scale of not more than 600 feet to the inch, delineating by appropriate markings the various tracts of land and territory served; the principal water production, storage, and distribution facilities; and the location of the various water system properties of applicant.

The effective date of this order shall be twenty days after the date hereof.
