S U P P L E M E N T A L    O R D E R

By Decision No. 68709, dated March 9, 1965, the Commission authorized Santa Barbara Transit Company to, among other things, operate two Routes; 5 Points Route (No. 8) and Cathedral Oaks Loop and Stow Canyon Loop (No. 9) on a 90-day trial basis. Article 4 of the order sets forth the conditions under which service could be abandoned. These conditions have been met by the applicant.

Therefore, good cause appearing, IT IS ORDERED that Appendix A of Decision No. 53442, is amended by incorporating therein First Revised Page 13 and First Revised Page 14, attached hereto, in revision to original pages 13 and 14. In all other respects Decision No. 53442 shall remain in full force and effect.
