OPINION AND ORDER

Alma Mae Marsh, doing business as Felix Marsh Transfer, holds radial highway common carrier, highway contract carrier, household goods carrier and city carrier permits. Decision No. 68527, dated January 22, 1965, in Application No. 47174, as amended, authorized her to assess rates and charges in cents per hour or per piece as named in Minimum Rate Tariff No. 4-B (used household goods) in lieu of the minimum rates otherwise applicable as set forth in Minimum Rate Tariff No. 2 in connection with the transportation of property for The Pacific Telephone and Telegraph Company, Western Electric Company and Radio Corporation of America.¹ The current authority is scheduled to expire with February 1, 1966. By this application, she seeks renewal of this authority.

Applicant states that since the granting of the current authority she has performed services for the shippers, all as alleged in the previous application and as set forth in Decision No. 68527, and all of the conditions under which the services were performed have remained the same.

¹ The rate authority was first granted by Decision No. 47215, dated June 5, 1952, in Case No. 4808, and has been extended and modified annually by subsequent decisions.

A copy of the verified application was served by mail on California Trucking Association on December 24, 1965. The application was listed on the Commission's Daily Calendar of December 28, 1965. No objection to the granting of the application has been received.
