FIFTH AMENDMENT TO ORDER OF SUSPENSION
AND INVESTIGATION

It appearing that on June 23, 1964, the Commission issued an amendment to its order of suspension and investigation which, among other things, suspended the effective date of certain revisions to its tariffs in Schedules Cal. P.U.C. Nos. 1-T, 6-T, 7-T, 53-T and 127-T filed by The Pacific Telephone and Telegraph Company under Advice Letter No. 8791 pending an investigation, hearing and decision thereon; that on February 3, 1965, by Decision No. 68540, the Commission extended said suspension to April 27, 1965, and that on March 26, 1965, The Pacific Telephone and Telegraph Company filed Supplement to Advice Letter No. 8791, requesting permanent suspension of said Advice Letter, and filed a substitute for it under Advice Letter No. 9010 to permit continuation of the investigation beyond the normal statutory limit of suspension; and on April 20, 1965 the Commission issued third amendment to order of suspension and investigation which permanently suspended the new or revised rates, classifications, practices or rules filed under Advice Letter No. 8791 and suspended to August 25, 1965 the new or revised rates, classifications, practices or rules set forth on tariff sheets in Schedules Cal. P.U.C. Nos. 1-T, 6-T, 7-T, 53-T and 127-T filed by The Pacific Telephone and

Telegraph Company under Advice Letter No. 9010, and on August 31, 1965 the Commission issued fourth amendment to order of suspension and investigation extending said suspension to February 25, 1966; and that on January 26, 1966, The Pacific Telephone and Telegraph Company filed Supplement to Advice Letter No. 9010, requesting permanent suspension of said Advice Letter, and filed a substitute for it under Advice Letter No. 9229 to permit continuation of the investigation beyond the normal statutory limit of suspension; therefore,

IT IS ORDERED that:

1. The operation of the new or revised rates, classifications, practices or rules set forth on tariff sheets in Schedules Cal. P.U.C. Nos. 1-T, 6-T, 7-T, 53-T and 127-T filed by The Pacific Telephone and Telegraph Company under Advice Letter No. 9010 are hereby permanently suspended.

2. The operation of the new or revised rates, classifications, practices or rules set forth on tariff sheets in Schedules Cal. P.U.C. Nos. 1-T, 6-T, 7-T, 53-T and 127-T filed by The Pacific Telephone and Telegraph Company under Advice Letter No. 9229 is hereby suspended to and including June 25, 1966, unless otherwise hereafter ordered.

3. The original order of investigation under Case No. 7693, dated August 27, 1963, shall remain in effect as to matters considered under Advice Letters Nos. 9229, 9010, and 8791 to the same extent as under Advice Letter No. 8548.

The Secretary is directed to cause a certified copy of this order to be served forthwith upon The Pacific Telephone and Telegraph Company.

The effective date of this order shall be the date hereof.
