OPINION

Greyhound Lines, Inc., requests the following authority:

- (a) To revise Route No. 16.01 between Manhattan Beach and Hermosa Beach, in order to adopt segments of Highland Avenue and Fifth Street in lieu of segments of Manhattan Beach Boulevard and Manhattan Avenue in Manhattan Beach.
- (b) To redescribe Route No. 16.06 to effect a technical correction of said route description without change other than to correctly designate "Imperial Boulevard" as "Imperial Highway" and "Coast Highway" as "Vista Del Mar".
- (c) To redescribe Routes Nos. 16.13 and 16.16 without change, other than highway renumbering, to delete the special conditions relating to use of detour routes pending completion of respective highways.
- (d) To redescribe all affected routes in Route Group No. 16 without change, except to adopt the new designations of highway as required by the 1963 amendment to the California Streets and Highways Code, Section 300 et seq., renumbering the State highway system.

It is alleged that the City of Manhattan Beach has been endeavoring to improve traffic and parking conditions in the downtown commercial area for the past two years; the City Council of Manhattan Beach has now formally approved the recommendation that buses be rerouted to proceed southerly on Highland Avenue to Fifth Street, thence over Fifth Street to Manhattan Avenue and the reverse when proceeding in a northerly direction; and the redescriptions of routes requested in paragraphs (b), (c), and (d) are technical in nature and for the purpose of more adequately describing applicant's present authority.

After consideration the Commission finds that public convenience and necessity require the granting of the application. A public hearing is not necessary.

ORDER

IT IS ORDERED that:

1. A certificate of public convenience and necessity is hereby granted to Greyhound Lines, Inc., authorizing the establishment and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers, baggage and express between the points and over the routes set forth in Third Revised Page 48, Second Revised Page 49, Third Revised Page 50, Fifth Revised Page 51 and Second Revised Page 51-A, attached hereto, as an extension and enlargement of and consolidation with, and subject to all the limitations and restrictions set forth in, the certificate granted by Decision No. 55893 and in particular subject to the provisions set forth in Section 3 of Appendix A thereof.

- 2. Appendix A of Decision No. 55893, as heretofore amended, is further amended by incorporating therein Third Revised Page 48 in revision of Second Revised Page 48, Second Revised Page 49 in revision of First Revised Page 49, Third Revised Page 50 in revision of Second Revised Page 50, Fifth Revised Page 51 in revision of Fourth Revised Page 51 and Second Revised Page 51-A in revision of First Revised Page 51-A.
- 3. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:
 - (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
 - (b) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file tariffs and timetables, in triplicate, in the Commission's office.
 - (c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.
 - (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98-A.

From junction California Highway 1 and California Highway 42 (Manchester Junction), over California Highway 1 to junction unnumbered highway (Airport Junction), to be operated as an alternate route.
