ORDER OF MODIFICATION

By Decision No. 69198, dated June 8, 1965, in this proceeding, A. W. Hays Trucking, Inc. acquired a certificate to operate as a cement carrier and an in-lieu certificate was issued consolidating the acquired right with applicant's original authority; however, Plumas County was not included in the original certificate because the supporting documentation indicated that the transportation relating to Plumas County was performed by applicant as a subhauler. In Wm. H. Shatto, Inc., 63 Cal. P.U.C. 781, the Commission subsequently found that it was immaterial whether an applicant acted as a prime carrier or a subhauler during the "grandfather" period.

Therefore, applicant's certificate will be amended to include Plumas County.

ORDER

IT IS ORDERED that:

1. Appendix A of Decision No. 69198 is hereby amended by substituting First Revised Page 1 attached hereto and made a part hereof in the place and stead of Original Page 1.

2. After the effective date hereof and on not less than ten days' notice to the Commission and to the public, applicant shall amend its tariffs presently on file with the Commission to reflect the authority herein granted.

The effective date of this order shall be twenty days after the date hereof.
