SUPPLEMENTAL OPINION AND ORDER

By Decision No. <u>70587</u>, entered today, the Commission found that the minimum rates established for the transportation of commodities named in List No. 5 of Item No. 525 of Minimum Rate Tariff No. 14-A are the just, reasonable and nondiscriminatory minimum rates for the transportation of coco bean shells or hulls, not ground. It concluded that by supplemental order in this proceeding Minimum Rate Tariff No. 14-A should be amended by including the commodity description coco bean, shells or hulls, not ground in said List No. 5 of Item No. 525.

IT IS ORDERED that:

1. Minimum Rate Tariff No. 14-A (Appendix A of Decision No. 67397, as amended) is further amended by incorporating therein, to become effective May 30, 1966, the revised page attached hereto, and by this reference made a part hereof, which revised page is numbered as follows:

Second Revised Page 31-C .

2. Tariff publications authorized to be made by common carriers as a result of the order herein may be made effective not earlier than the tenth day after the effective date of this order, and may be made effective on not less than ten days' notice to the Commission and to the public if filed not later than sixty days after the effective date of the minimum rate tariff pages incorporated in this order.

Common carriers, in establishing and maintaining the rates authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the rates published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.

The effective date of this order shall be twenty days after the date hereof.
