### <u>O P I N I O N</u>

Dominic A. Mannino, doing business as M & M Charter Lines, requests authority to sell and transfer and M & M Charter Lines, Inc., a California corporation, requests authority to purchase and acquire certain property and operating authority as a passenger stage corporation and as a charter party carrier of passengers. The information set forth in the application is supplemented and revised by letter from James H. Lyon, the attorney, dated March 9, 1966, and amended Exhibits B and C, all of which are hereby received in evidence as Exhibit 1.

The certificate of public convenience and necessity, which was granted by Decision No. 60045, dated May 31, 1960, in Application No. 41776, has been amended by the following Decisions Nos.: 60432, 60770, 61590, 61887, 62900, 63212, 64162, 65367, 66319, 67270, 67387, 68868, 69039 and 69494, and authorizes service in the general area of the County of Los Angeles and to various points specified in said certificate as amended. Mannino operates throughout the State of California pursuant to authority granted by Permit TCP-17.

The property to be transferred consists of all of the assets of Dominic A. Mannino, doing business as M & M Charter Lines, except land and the building and improvements thereon. These assets consist of prepaid interest, prepaid expenses, revenue equipment, autos and service cars, and furniture and equipment, the total book value of which is \$585,051.79. Mannino also requests authority to lease the land, buildings and improvements to M & M Charter Lines, Inc., pursuant to the terms and conditions of a lease which are substantially as set forth in Exhibit D attached to the application herein.

Mannino owns all the \$10,000 capital stock of M & M Charter Lines, Inc., which is issued and outstanding. The consideration for the transfer of the assets is the assumption by M & M Charter Lines, Inc., of the \$486,379.10 indebtedness of Mannino. The excess of book value of assets over the assumed indebtedness and capital stock will become paid-in surplus in the amount of \$89,399.69 as of October 1, 1965.

After consideration, the Commission finds that the proposed transfer would not be adverse to the public interest, that the assumption of the indebtedness of Dominic A. Mannino by M & M Charter Lines, Inc., as shown on amended Exhibit C of Exhibit 1 should be authorized, and that the leasing of the storage and maintenance facilities and office space by Dominic A. Mannino to M & M Charter Lines, Inc., upon terms and conditions substantially as set forth in Exhibit D attached to the application herein should be authorized.

On the basis of these findings we conclude that the application should be granted. A public hearing is not necessary.

The authorization herein granted shall not be construed as a finding of value of the rights and properties herein authorized

to be transferred. The certificate herein involved will be revoked and a restated certificate will be issued in appendix form. As a charter-party carrier of passengers permit is not transferrable, M & M Charter Lines, Inc., should apply for its own charter-party carrier of passengers permit.

#### IT IS ORDERED that:

1. On or before September 1, 1966, Dominic A. Mannino may sell and M & M Charter Lines, Inc., may purchase and acquire, the operative rights, excluding charter-party carrier of passengers Permit TCP-17, and property referred to in the application and Exhibit 1 herein.

2. Within thirty days after the consummation of the transfer herein authorized, M & M Charter Lines, Inc., shall notify the Commission, in writing, of that fact and within said period shall file with the Commission a true copy of any bill of sale or other instrument of transfer which may be executed to effect said transfer.

3. Dominic A. Mannino and M & M Charter Lines, Inc., shall amend or reissue the tariffs and timetables on file with the Commission, naming rates and rules governing the common carrier operations herein to show that Dominic A. Mannino has withdrawn or canceled, and M & M Charter Lines, Inc., has adopted or established as its own, said rates and rules. The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the consummation of the transfer herein authorized. The tariff and timetable filings made

pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98-A.

4. On or before the end of the third month after the consummation of the transfer as herein authorized, M & M Charter Lines, Inc., shall cause to be filed with the Commission, in such form as the Commission may prescribe, an annual report, or reports, related to the operations of the seller for the period commencing with the first day of the current year to and including the effective date of the transfer.

5. Concurrently with the effective date of the tariff filings required by ordering paragraph 3 hereof, the operative rights granted by Decision No. 60045, as amended by Decisions Nos. 60432, 60770, 61590, 61887, 62900, 63212, 64162, 65367, 66819, 67270, 67387, 66868, 69039 and 69494 are hereby revoked and, in place and stead thereof, a certificate of public convenience and necessity is granted to M & M Charter Lines, Inc., authorizing it to operate as a passenger stage corporation as defined in Section 226 of the Public Utilities Code, between the points and over the routes particularly set forth in Appendix A attached hereto and made a part hereof.

6. On or before September 1, 1966, M & M Charter Lines, Inc., is authorized to assume the indebtedness of Dominic A. Mannino referred to in the application herein and shown on amended Exhibit C of Exhibit 1 herein.

7. On or before September 1, 1966, Dominic A. Mannino is authorized to lease to M & M Charter Lines, Inc., the land, buildings and improvements referred to in the application upon terms and conditions substantially as set forth in Exhibit D which is attached to the application.

The effective date of this order shall be twenty days after the date hereof.
