## OPINION

Greyhound Ifnes, Inc. requests authority to operate buses in excess of thirty-five feet in length and in excess of ninety-six inches in width on State Route 1 between Pedro and Half Moon Bay, and requests restatement of existing authority due to highway renumbering and route changes in the following areas: San Francisco Peninsula, Marin County, Contra Costa County, Long Beach - Santa Monica, and San Diego area.

It is alleged that service in the proposed areas is characterized by peak-load conditions at certain times of the day, and that operation of the over-size equipment is less expensive than operating extra sections.

Aiter consideration, the Commission finds that public convenience and recessity require the granting of the application. A public hearing is not necessary.

IT IS ORDERED that:

1. A certificate of public convenience and necessity is hereby granted to Greybound Ines, Inc., authorizing the establishment and operation of service as a passenger stage corporation, as
that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers, baggage and express between the points and over the routes set forth In First Revised Page 100, First Revised Page 102, First Revised Page 103, First Revised Page 104, FIrst Revised Page 105, First Revised Page 107, Second Revised Page 108, Third Revised Page 109, Second Revised Page 110, and Second Revised Page 111, attached hereto, as an extension and enlargement of and consolidation with, and subject to all the limitations and restrictions set forth in, the certificate granted by Decision No. 55893 and in particular subject to the provisions set forth in Section 3 of Appendix A thereof.
2. 3. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:
(a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
(3) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file tariffs and timetables, in triplicate, in the Comission's office.
(c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.
(d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and $98-\mathrm{A}$.
The effective date of this order shall be twenty days after the date hereof.
