SUPPLEMENTAL ORDER

By Decision No. <u>70919</u>, issued today, the Commission canceled Minimum Rate Tariff No. 16, and related provisions of other minimum rate tariffs, which tariff and related provisions were under suspension. The decision also provided that, in order to avoid duplication of tariff distribution, Minimum Rate Tariff No. 5 should be amended by a separate order.
