SUPPLEMENTAL OPINION AND ORDER

Decision No. 69724, dated September 28, 1965, among other things granted a certificate to applicant Rolling Green Utilities, Inc., authorizing the construction of a public utility gas system.

Paragraph 6 of the order provides:

"Applicant shall file with this Commission monthly statements of the heating value of liquefied petroleum gas being served."

Applicant requests relief from the foregoing requirement. In lieu thereof, applicant proposes to include in its filed tariffs a statement that the minimum heating value of the gas served is 2,185 Btu per cubic foot.

A Commission staff report, hereby received as Exhibit No. 3, recommends that the tariff provision proposed by applicant relative to minimum heating value be authorized but that annual instead of monthly statements of actual tested heating value be filed with this Commission. We find that the staff's recommendations are reasonable and conclude that Decision No. 69724 should be modified to reflect those recommendations.

IT IS ORDERED that:

1. Within thirty days after the effective date of this order, applicant Rolling Green Utilities, Inc. shall file as part of its Rule No. 2, Description of Service, a statement that the minimum heating value of the gas served is 2,185 Btu per cubic foot. Such filing shall comply with General Order No. 96-A. The effective date of the revised sheets shall be four days after the date of filing.

2. Upon compliance with the foregoing paragraph, applicant is authorized to substitute annual statements of the heating value of liquefied petroleum gas being served, in lieu of the monthly statements required by Paragraph 6 of the order in Decision No. 69724. The first such "annual" statement shall be filed within two months after service is first rendered to the public under the revised Rule No. 2 required herein.

3. In all other respects, Decision No. 69724 shall remain in full force and effect.

The effective date of this order shall be twenty days after the date hereof.
