Application of GREYHOUND LINES, INC. for authority to revise, reauthorize, redescribe and revoke certain routes in Intercity Route Group 4, Urban Route Groups UR-2 (Davis), UR-3 (Dixon), UR-10 (Sacramento) and UR-19 (Vallejo), Sacramento, Solano, and Yolo Counties; and for incidental relief in miscellaneous route groups including highway renumbering and technical corrections with no route changes involved.

# <u>O P I N I O N</u>

Greyhound Lines, Inc. requests authority to revise, reauthorize, redescribe and revoke certain routes in Intercity Route Group 4, Urban Route Groups UR-2 (Davis), UR-3 (Dixon), UR-10 (Sacramento) and UR-19 (Vallejo).

Most of the changes are of a technical nature which will simplify main-line route descriptions in the use of Interstate Highway 80, in the Counties of Sacramento, Solano, and Yolo. A number of changes consist of highway renumbering with no route changes involved.

After consideration, the Commission finds that public convenience and necessity require the granting of the application. A public hearing is not necessary.

# ORDER

# IT IS CRDERED that:

1. A certificate of public convenience and necessity is granted to Greyhound Lines, Inc., authorizing the establishment

and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers, baggage and express between the points and over the routes set forth in Second Revised Page 8, Second Revised Page 9, Second Revised Page 19, Third Revised Page 22, Third Revised Page 23, First Revised Page 31, First Revised Page 66, Second Revised Page 67, First Revised Page 76 and First Revised Page 39, attached hereto, as an extension and enlargement of and consolidation with, and subject to all the limitations and restrictions set forth in, the certificate granted by Decision No. 55893 and in particular subject to the provisions set forth in Section 3 of Appendix A thereof.

2. Appendix A of Decision No. 55893, as heretofore amended, is further amended by incorporating therein Second Revised Page 8, Second Revised Page 9, Second Revised Page 19, Third Revised Page 22, Third Revised Page 23, First Revised Page 31, First Revised Page 66, Second Revised Page 67, First Revised Page 76, and First Revised Page 69, in revision of First Revised Page 8, First Revised Page 9, First Revised Page 19, Second Revised Page 22, Second Revised Page 23, Original Page 31, Original Page 66, First Revised Page 67, Original Page 76 and Original Page 89.

3. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- (b) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file tariffs and timetables, in triplicate, in the Commission's office.

- (c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.
- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98-A.

From East Vallejo, over authorized urban routes for the City of Vallejo to Sonoma Boulevard, thence over Sonoma Boulevard to junction Interstate Highway 80 (Morrow Cove Junction).

\*4.09 - Between East Travis Junction and Travis Air Force Base:

From junction North Texas Road and Air Base Parkway (East Travis Junction), over Air Base Parkway to Travis Air Force Base. (1)
