O P I N I O N

J. D. Transportation Co., a corporation, holds a certificate of public convenience and necessity as a public utility warehouseman to operate 31,200 square feet of warehouse or storage floor space in the City of Los Angeles.¹

Applicant requests authority to move its public utility warehouse facility from 200 Seaside Avenue, Terminal Island, to 315 Marine Avenue, Wilmington.² Applicant also requests authority to make the necessary tariff publications for the change in location on ten days' notice.

The application states that applicant has been required to vacate the premises at the Terminal Island location, and has entered into a lease-purchase agreement for a warehouse building in Wilmington. Said building contains a total floor space of 75,000 square feet, of which 45,000 square feet will be used by applicant for warehousing and trucking, and 30,000 square feet will be leased to a private company. Applicant alleges that the floor space to be used by it in the conduct of its public utility warehouse service will not exceed the 31,200 square feet set forth in its certificate, plus the expansion of 50,000 square feet permissible under Section 1051 of the Public Utilities Code.

The application states that no changes in rates will result from the granting of the authority requested.

The application shows that it was served on competing warehousemen in the Los Angeles Harbor district of the City of Los Angeles. The application was listed on the Commission's Daily Calendar of May 24, 1966. No protests have been received.

After consideration, the Commission finds that transfer of location of the public utility warehouse facility as proposed in the application would not be adverse to the public interest, and that a public hearing is not necessary. The Commission concludes that the application should be granted.

ORDER

IT IS ORDERED that:

1. J. D. Transportation Co. is hereby authorized to transfer, as proposed in the application herein, the location at which public utility warehouse service is to be performed within the City of Los Angeles pursuant to the certificate of public convenience and necessity granted by Decision No. 68917.

2. Tariff filings required to be made as a result of the order herein may be made effective not earlier than the tenth day after the effective date of this order on not less than ten days' notice to the Commission and the public.

The effective date of this order shall be ten days after the date hereof.
