O P I N I O N

Ora B. Smith and Chester R. Smith, copartners doing business as Santa Cruz Transit Company, request authority to extend service to the Santa Cruz Campus of the University of California for a trial period of ninety days.

It is alleged that approximately 1,450 students will be in attendance at the Santa Cruz Campus this fall, many of whom will require public transportation, and because of the economically marginal status of applicants' present operations it is requested that the service be conducted on a trial basis for a period of ninety days. Applicants also request that the proposed extension be authorized as soon as possible.

After consideration the Commission finds that public convenience and necessity require the granting of the application. A public hearing is not necessary.

O R D E R

IT IS ORDERED that:

1. Appendix A of Decision No. 62133, dated June 13, 1961 in Application No. 43459, is hereby amended by substituting Second Revised Page 2, attached hereto and made a part hereof, in place of First Revised Page 2.

2. After the effective date hereof and on not less than two days' notice to the Commission and to the public, applicants shall amend their tariffs and timetable presently on file with the Commission to reflect the authority herein granted.

The effective date of this order shall be the date hereof.

Route A - Beginning at the intersection of Pacific Avenue and Soquel Avenue, along Pacific Avenue to Mission Street, Bay Street, Lighthouse Avenue, Santa Cruz Street, Delaware Avenue, Fair Avenue, Mission Street, and Pacific Avenue to Soquel Avenue.

U. C. Campus Route

Commencing at the intersection of Mission Street and Bay Street, thence along Bay Street to the University entrance on High Street. Then through the campus enroute back to Mission Street via Moore Street, Laurent Street, King Street and Walnut Street.
