ORDER REVOKING WAREHOUSE OPERATIVE RIGHT

Albert Coleman, C. J. Coleman and Mrs. Frank J. (Corrine) Brewster, doing business as Escalon Warehouse Co., possess a prescriptive operative right as a public utility warehouseman for the operation of storage or warehouse floor space at Escalon.

A. L. Coleman, partner in Escalon Warehouse Co., has informed the Commission by letter that the utility has not done any public utility warehouse business for several years and does not contemplate doing any in the future and requests that the operative right involved be revoked.

In the circumstances, it appears, and the Commission finds, that the revocation of the prescriptive warehouse operative right as requested will not be adverse to the public interest. The Commission concludes that the prescriptive warehouse operative right should be revoked and the tariff applicable to the service thereunder should be canceled. A public hearing is not necessary.

IT IS ORDERED that:


1. The prescriptive operative right as a public utility warehouseman possessed by Albert Coleman, C. J. Coleman and Mrs. Frank J. (Corrine) Brewster, doing business as Escalon Warehouse Co., as determined by order dated August 23, 1960, in Case No. 6879, is hereby revoked.

2. Jack L. Dawson, Agent, is hereby authorized and directed to cancel the participation of Albert Coleman, C. J. Coleman and Mrs. Frank J. (Corrine) Brewster, doing business as Escalon Warehouse Co., from his Warehouse Tariff No. 38, Cal.P.U.C. No. 203, on file with the Commission, such cancellation to be made within ninety days after the effective date of this order on not less than ten days' notice to the Commission and the public.

The Secretary is directed to cause service of a certified copy of this order to be made upon Albert Coleman, C. J. Coleman and Mrs. Frank J. (Corrine) Brewster, or to mail a certified copy thereof to them at their last known address as shown in the Commission's records and to mail a copy of this order to Jack L. Dawson, Agent.

The effective date of this order shall be the thirtieth day after such service upon Albert Coleman, C. J. Coleman and Mrs. Frank J. (Corrine) Brewster or after the above mailing to them unless before such effective date there shall have been filed with this Commission a written request for public hearing, in which event the effective date of this order shall be stayed until further order of the Commission.




