# Decision No. 71455

### BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of C. H. MILLER, an individual, doing business as C. H. MILLER TRANSPORTATION to sell to BOYD TRUCKING CO., a California corporation, certain operating authorities evidenced by a certificate of public convenience and necessity.

Application No. 48740 (Filed August 25, 1966)

## <u>O P I N I O N</u>

C. H. Miller, presently engaged in the transportation of lumber and forest products throughout an extensive area within the State, requests authority to sell and transfer a portion of his certificated authority to Boyd Trucking Co.

Applicant was granted authority by Decision No: 59551 dated January 26, 1960, as amended by Decision No. 59701, dated February 23, 1960 to conduct operations between points within California. Basically Miller wishes to restrict his operation to shipments of lumber and forest products originating in or destined to points in Butte County and limited commodities between various points and to sell the operating rights applicable to the balance of his present operations. The agreed cash consideration is. \$20,000, payable as follows: Five thousand dollars down and the balance upon authorization of the sale by this Commission and the Interstate Commerce Commission.

Applicant Buyer is a California corporation presently engaged in the transportation of lumber and forest products as a permitted carrier. It owns and operates 37 units of equipment and as of December 31, 1965, indicated a net worth in the amount of \$159,326.47.

After consideration the Commission finds that the proposed transfer would not be adverse to the public interest. A public hearing is not necessary.

The authorization herein granted shall not be construed as a finding of the value of the rights and properties herein authorized to be transferred.

Boyd Trucking Co. is hereby placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business over a particular route. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

## <u>order</u>

IT IS ORDERED that:

1. On or before May 1, 1967, C. H. Miller may sell and transfer, and Boyd Trucking Co. may purchase and acquire, the operative rights referred to in the application.

2. Within thirty days after the consummation of the transfer herein authorized, Boyd Trucking Co. shall notify the Commission, in writing, of that fact and within said period shall file with the Commission a true copy of any bill of sale or other instrument of transfer which may be executed to effect said transfer.

3. Boyd Trucking Co. shall file tariffs with the Commission naming rates and rules governing the common carrier operations acquired herein and C. H. Miller shall amend or reissue the tariffs

on file with the Commission so as to name rates and rules governing his remaining highway common carrier operations. The tariff filings shall be made effective not earlier than thirty days after the effective date of this order on not less than thirty days' notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the consummation of the transfer herein authorized. The tariff filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80-A.

4. Concurrently with the tariff filings required by ordering paragraph 3 hereof the operating authority granted by Decision No. 59551, dated January 26, 1960, as amended by Decision No. 59701, dated February 23, 1960 is hereby revoked and simultaneously therewith certificates of public convenience and necessity are hereby granted to C. H. Miller and Boyd Trucking Co. authorizing the transportation of property as highway common carriers between the points and over the routes set forth in Appendices A & B attached hereto and made a part hereof.

5. In providing service pursuant to the certificate herein granted, Boyd Trucking Co. shall comply with and observe the following service regulations:

(a) Within thirty days after the effective date hereof, Boyd Trucking Co. shall file a written acceptance of the certificate herein granted. Boyd Trucking Co. is placed on notice that, if it accepts the certificate of public convenience and necessity herein granted, it will be required, among other things, to comply with and observe the safety rules of the California Highway Patrol and the insurance requirements of the Commission's General Order No. 100-D. Failure to comply with and observe the safety rules, or the provisions of General Order No. 100-D, may result in a cancellation of the operating authority granted by this decision.

(b) Boyd Trucking Co. shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.
