Sierra Distributing, Ltd., presently engaged in the transportation of property as a highway common carrier, requests that its certificate be amended by deleting therefrom authority to transport Peanut Butter (Peanut Paste) and Soap between Sacramento, on the one hand, and San Francisco, San Jose, Alameda, Oakland, Pittsburg, Stockton and Perkins, on the other hand.

It is alleged that applicant is also engaged in the transportation of property as a permitted carrier; for a number of years it has transported soap and related products, as well as peanut butter, from the Sacramento plant of Procter and Gamble Company to the aforenamed points as a contract carrier; and it is desired by all parties to continue the contractual arrangement.

After consideration the Commission finds that the requested authority would not be adverse to the public interest. A public hearing is not necessary.
