ORDER OF REVOCATION

Decision 70025, issued November 30, 1965, ordered respondent to collect undercharges totaling \$2,223.64. The decision also ordered payment of a fine in the amount of said undercharges.

Respondent has collected \$598.99 in undercharges and has filed a claim in bankruptcy for \$1,624.65 against a bankrupt shipper. A partial payment of the fine in the amount of \$305.91 has been made. The time for payment of the balance of the fine (\$1,917.73) was extended to May 18, 1967 by Decision 70881, dated June 21, 1966.

A check in the amount of \$249.62, dated August 15, 1966, submitted by respondent for payment of Transportation Rate Fund fees for the 2nd quarter of 1966, after having been deposited was returned by the bank to the Commission because of insufficient funds. On September 2, 1966 a notice to redeem the check was sent to respondent. The notice was returned with the notation 'We are out of business and out of funds."

Section 5007 of the Public Utilities Code provides for revocation of any permit when the carrier is in default in the payment of fees.

Respondent's Radial Highway Common Carrier and City
Carrier permits were suspended September 18, 1966 for failure to
have evidence of liability insurance protection on file as required
by the Commission's General Order No. 100-D.

The Commission finds that respondent has not paid the transportation Rate Fund fees for the second quarter of 1966 and has failed to maintain evidence of insurance on file as required by General Order 100-D.

The Commission concludes that respondent's permits should be revoked. Terminal Transportation Inc. is placed on notice that no highway carrier permit or city carrier permit will be issued to it or to anyone who was an officer or director of respondent on the effective date of Decision No. 70025 until the balance of the fine and the Transportation Rate Fund fees are paid.

ORDER

IT IS ORDERED that Radial Highway Common Carrier Permit No. 19-56607 and City Carrier Permit No. 19-56608 issued to Terminal Transportation Co., Inc. are revoked.

The Secretary of the Commission is directed to cause service of this order to be made upon respondent. The effective date of this order shall be twenty days after the completion of such service. . H
