Decision No. 71479

BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of MARIAN LEE, doing business as RADIO PAGING COMPANY, for an order authorizing (A) Radio Paging Company to sell and Tel-Page, Inc., a corporation, to buy the properties owned by Marian Lee consisting of a one-way radio paging service, call letters KMB-306, License No. 1979-C2-R-63, together with the operative rights thereto; (B) Radio Paging Company to withdraw from the one-way radio paging service; (C) Tel-Page, Inc., a corporation, to engage in the one-way radio paging service.

SUPPLEMENTAL ORDER

Decision No. 70829, entered on June 8, 1966, which became effective on June 28, 1966, authorized Marian Lee to transfer her radio telephone operating rights to Tel-Page, Inc. within 120 days after the effective date of that decision. This authorization will expire on October 27, 1966. Tel-Page has filed a written request seeking an extension of time in which to consummate the transfer. Tel-Page states that the transfer cannot be effectuated until it is approved by the Federal Communications Commission and that Commission has not yet acted because of a backlog of other similar applications. Tel-Page seeks an order extending the time in which to complete the transfer to a reasonable time after the Federal Communications Commission has acted on Tel-Page's application before it. The Commission is of the opinion that an extension of time should be granted, but that the extension sought by Tel-Page is too broad and vague. A one year extension will be granted. If additional time is needed appropriate relief can be requested.

ORDER

IT IS ORDERED that Ordering Paragraph 1 of Decision No. 70829, which presently reads as follows:

"I. Within one hundred twenty days after the effective date of this order Marian Lee may transfer her public utility radio-telephone operating rights (call letters KMB-306, License No. 1979-C2-R-63) and properties to Tel-Page, Inc., in accordance with the agreement attached to the amended application as Exhibit A. Within thirty days after the actual transfer, Tel-Page, Inc., shall notify this Commission, in writing, of the date upon which the transfer was consummated."

is hereby modified as follows:

On or before November 1, 1967 Marian Lee may transfer her public utility radio-telephone operating rights (call letters KMB-306, License No. 1979-C2-R-63) and properties to Tel-Page, Inc., in accordance with the agreement attached to the amended application as Exhibit A. Within thirty days after the actual transfer, Tel-Page, Inc., shall notify this Commission, in writing, of the date upon which the transfer was consummated.
