## OPINION

I P G Iransportation Corp. requests authorlty to sell and transfer and I. M. Pepper, doing business as PEP's Kerosene Service, requests authority to purchase and acquire a certificate of public convenience and necessity authorizing the transportation of Fetroleum products as an irregular route carrier.

Applicant seller acquired the operating authorlty by Decision No. 53011 dated May 1, 1956 in Application No. 37836. The agreed cash consideration is $\$ 1,500$. Applicant buyer Is presently engaged in the transportation of petroleum products as a contract carriex. As of July 31, 1966, he indicated a net worth in the amount of $\$ 87,259$.

After consideration the Comossion finds that the proposed transfer would not be advexse to the public interest. A public hearing is not necessary.

The authorization herein granted shall not be construed as a finding of the value of the rights and properties herein authorized to be transferred.

II IS ORDERED that:

1. On or before April 1, 1967, I P G Transportation Corp. may sell and transfer, and I. M. Pepper way purchase and acquire, the operative rights referred to in the application.
2. Within thirty days after the consumpation of the transfer herein authorized, I. M Pepper shall notify the Comaission, in writing, of that fact and within said period shall file with the Commssion a true copy of any bill of sale or other fnstrument of transfer which may be executed to effect said transfer.
3. L. M. Pepper shall amend or relssue the tariffs on file with the Comaission, naming rates and rules governing the comon Carrier operations herefn to show that he has adopted, or established, as his own, said tates and rules. The tariff filings shall be made effective not earlier than thirty days after the effective date of this order on not less than thirty days' notice to the commission and the public, and the effective date of the tariff filings shall be concurrent with the consumation of the transfer herefn authorized. The tariff filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80-A.
4. On or before the end of the third month after the consumation of the transfer as herein authorized, L. M. Pepper shall cause to be filed with the Comonssion, in such form as the Commission may prescribe, an annual report, or reports, related
to the operations of the seller for the period commencing with the first day of the current year to and including the effective date of the transfer:
